## **REVIEW OF MINUTES:**

 May 2011 minutes: D Wallet moved to approve, B Dick seconded, minutes approved (CLOSED)

## **POTENTIAL BOARD MEMBERS:**

- Dave Wenthe attended as a potential board member (until this term is up), G. DiStefano made motion to approve, B. Dick seconded, motion was passed
- Kim Deiter is also a potential candidate, but was unable to attend

<u>AHOA WEBSITE:</u> Patrick Gridley (704 Allenview) – attended meeting to explain proposal (4-6 hours of coding at \$50/hour) for developing and maintaining website for <a href="www.allenview.org">www.allenview.org</a>; G. DiStefano made motion to approve, L. Dorsey seconded, motion approved

**POOL:** T Bedard was not in attendance – emailed pool report and information of an incident from June 28, 2011

- D Wallet stresses that pool manager is to be told that his presence is expected at every meeting
- Per D Herman, Pool manager has his pesticide license
- T Bedard will put minor pool maintenance items on credit card and submit for reimbursement, per B Dick
- Swim lessons begin next week 18 kids are registered for lessons according to T Bedard, the guards are giving the instruction – it was decided that a Red Cross water safety instructor should instruct instead
  - D Herman will call T Bedard to find a certified instructor to conduct the classes or the classes should be cancelled
- W4's still have not been completed by pool employees
- Concerning incident of June 28, 2011 involving Lifeguards and resident, after call to police, D Herman will talk to the Board's legal representation about options

**MANAGERS REPORT:** J. Rieman submitted reports during month via email; no formal report given

#### MAINTENANCE REPORT: B. Dick reported

- Bowers, 960 Allenview agreed to pay half (\$1750) for tree removal on property; J Rieman recommended a deposit from Bowers to put process in motion
- Ask Shopes to provide and spread tan bark in common areas J Rieman motioned, L Dorsey seconded, motion passed
- E Davis is repairing frames of mailboxes in townhome areas
- Shopes sprayed islands for weeds and cut down weeds in retention ponds
- B Dick will discuss with Shopes: resodding at 700, 819, and Joyce Elfreth's row

- 772 Allenview: high bank take out weeds and shrubs and tan bark for now
- Cutting down 10 trees in wooded area some time next week

- Recommendation for tree planting planting of fast growing trees on border of Allenview and Autumn Chase – homeowners to be asked to purchase a tree towards this effort – be put on next agenda (B Dick) – G DiStefano suggests expand to include replanting of trees in wooded area as well

  - o 460 Allenview trash behind back
  - o 946 Allenview tent or awning and star on brick on the front and not a full view screen door
  - o 932 Allenview pallets of building supplies
  - o 914 and 942 Allenview flags hanging over front porch and signs
  - o There are now 3 townhomes with a garden in the front and 2 with a garden in the back
  - o Townhome that backs up to Hertzler painted the deck white
